Dear Dennis

I am writing to you, following ExCom's decision at today's teleconference meeting.

I am truly delighted to say that, as a result of the CICMC application to ICMCI, we are happy to grant CICMC provisional membership of ICMCI with immediate effect.

Since you are so well related to CAMC we do not find a particular initial visit at the site necessary before your acceptance as a Provisional Member.

As a Provisional Member, you are expected to develop your own certification programme to be ready for it to be assessed as equivalent to the standards set by ICMCI for the Certified Management Consultant qualification. Once this assessment has been successful and you have been in existence for, usually, four years, you will be able to be offered Full Membership of ICMCI. Until then we expect you to continue your certification processes with assistance from CAMC. ICMCI would like to take this opportunity to acknowledge the support that CAMC has provided to CICMC.

We believe that your initial geographical boundary shall be centred on the Caricom area, which includes 14 countries: Antigua and Barbuda, the Bahamas, Barbados, Belize, Dominica, Grenada, Guyana, Haiti, Jamaica, St. Kitts and Nevis, Saint Lucia, St. Vincent and the Grenadines, Suriname, Trinidad & Tobago.

Potentially you may also include Anguilla, Aruba, British Virgin Islands, Cayman Islands, French Guiana, Guadeloupe and Martinique, Montserrat, Netherlands Antilles and Turks and Caicos Islands. If the area should in the future be changed, we would appreciate to be kept informed.

We wish to welcome CICMC to ICMCI. We wish CICMC every continuing success as both a professional body representing management consultants and as a pioneer in developing the concept of regional grouping to form a viable Institute where the size of the economies of the constituent countries would not support such an Institute for each country.
